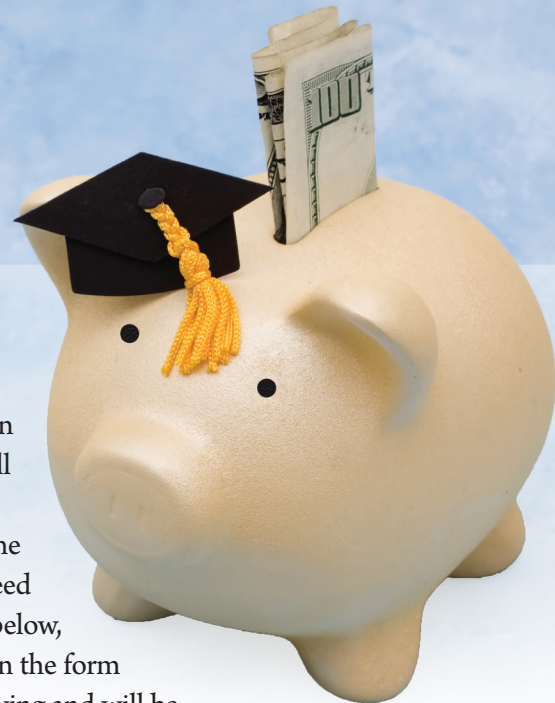
## Prizes to be awarded
