Petitions for Board of Directors are available

What does it mean to serve on the board?

Serving on Norris Electric’s board means you’re making a difference locally, using your individual talents and perspective to guide big decisions about the co-op that in turn benefit the larger community. While day-to-day decisions are made by co-op staff, major decisions are made by the board, whose mission is to look out for the vitality of the co-op and the community it serves. On a granular level, Norris Electric board members typically provide input and guidance on:

- budgets
- co-op goals and direction
- co-op’s community/charitable contributions
- capital investments and upgrades in equipment and technology
- renewable investments and energy mix
- co-op’s role and involvement in economic development
- analysis and approval of the Purchase Power Agreement

The term of four directors will expire with the February 2025 annual meeting. The board seats are up for election, with one board member to be elected from each county: Clark, Crawford, Cumberland and Jasper.

Four incumbents intend to seek reelection. They are Justin Parcel, Clark County; Kurt Holscher, Crawford

County; Ted Helmink, Cumberland County; and Dave Sheppard, Jasper County. Any members who reside and take service in any of the four counties above may submit a petition to be placed on the ballot.

According to the cooperative bylaws, all candidates must submit a petition signed by at least 25 members to be placed on the ballot. Requests for petitions will be available Nov. 15, 2024, and may be obtained by contacting the cooperative office. Petitions must be returned to the cooperative office by noon on Dec. 23, 2024.

Petitioners with qualified petitions will be placed on the ballot. Ballots will be mailed 30-45 days prior to our annual meeting. The results will then be announced at our annual meeting, to be held on Feb. 22, 2025.

Here's a brief rundown of the scholarships available.

- Ten scholarships will be awarded to high school seniors whose parent(s) are Illinois electric co-op members, giving these students a bright start on their educational journey.
- The Earl W. Struck Memorial Scholarship is reserved for a student whose parent is an Illinois electric cooperative employee or director, honoring the legacy of service within our cooperative family.
- Five scholarships are dedicated to students enrolling full-time at a two-year Illinois community college, who are also children of an electric cooperative member in Illinois.
- The LaVern and Nola McEntire Memorial Lineworker's Scholarship is designed for those ready to light up the world by pursuing a career in linework and are enrolled or plan to enroll at Lincoln Land Community College's lineworker program. This scholarship supports students of co-op members, relatives of employees or directors, and those who have served or are currently serving in the armed forces or National Guard.

Don't miss out on this opportunity! The general scholarship application deadline is Dec. 31, 2024, and the lineworker scholarship is due by April 30, 2025. Residential electric heat rate available

Norris Electric offers an electric heat rate? The rate is available to residential members of the cooperative for uses where electricity is the sole source of all space heating energy. The heat source must be for the whole house and permanently installed. Types of electric heat which qualify include geothermal heat pumps, air source heat pumps and electric furnaces.

The only obligation is the member must continue the electric heat rate for 12-month increments.

The electric heat rate offers a lower rate in the winter months that more than offsets the slightly higher summer rate when compared to our standard rate.
